## 2020 Mayoral Election and Governing Statues

In addition to the presidential, federal, state, and various county elections, being held in 2020, Clarkston registered voters are going to the polls to choose a new Mayor who will take office at the December 1, 2020, City Council Work Session.

The City held a qualifying period for the special election to fill the Mayor's position on the City of Clarkston's City Council on three (3) consecutive days, Monday, September 14, 2020 to Wednesday, September 16, 2020, 9:00 a.m. to 4:30 p.m., at Clarkston City Hall Annex, 1055 Rowland Avenue. During that qualifying period two individuals qualified to run for the vacant Mayor seat: Beverly Burks and Yterenickia Bell (**See Front Page For Candidates Information**).

- [Georgia Constitution Article 2, Section 2, Paragraph V](#), provides that the office of an elected municipal official immediately becomes vacant upon the official qualifying for another elected office, which occurred on March 4, 2020, when the previous Clarkston Mayor (Ted Terry) qualified as a candidate for DeKalb County Commission.
- [Clarkston City Charter, Section 2.05 \(a\)](#) provides that a vacancy in the office of Mayor shall be declared by the Vice Mayor (**Awet Eyasu**) at a regular meeting of the City Council and shall be affirmed by a majority vote of the City Council (**Jamie Carroll, Laura Hopkins, Debra Johnson, Ahmed Hassan**), which occurred on May 5, 2020.
- [Clarkston City Charter, Section 2.05 \(c\)](#) provides that such a vacancy is to be filled by a special election if the term of the vacant seat will not expire in the next twelve (12) months (term to conclude December 31, 2021). Furthermore, Clarkston City Charter, Section 2.05 (c) provides that such a special election shall be held on a date provided by GA code, Section 21-2-450(c), which is the date of the General Election to be held on November 3, 2020.



## Where to Vote in Clarkston on Election Day, November 3, 2020

## 2020 Census Ends Early Via Supreme Court Ruling

Although the 2020 Census completion deadline date was set and reaffirmed judicially to end on October 31, 2020 the Trump Administration via a Supreme Court ruling officially ended 2020 Census data collection on October 15th. As a recourse, prior to the Supreme Court ruling, local, including the City of Clarkston, and state governments and advocacy groups throughout the country filed a lawsuit that charged the Administration with violating the U.S. Constitution's Fourteenth Amendment, Article I, Section 2 and related statutes that requires every resident in the United States, be counted in the census.



While a lower court upheld the 2020 Census deadline date of October 31, 2020, the Supreme Court's ruling dealt a bitter defeat to local, state governments and advocacy groups who brought the lawsuit to keep the population count going to prevent White House officials, instead of the Census Bureau experts, determining representation in the House of Representatives and in state and local governments---commonly known as redistricting.

Another reason that the City of Clarkston joined the lawsuit along with the other U.S. local and state governments was learning that the Trump Administration had plans to exclude undocumented immigrants from the count. Excluding undocumented immigrants could have potentially seismic political ramifications. Time will tell if the Supreme Court's ruling will allow the Administration to execute its---redistricting and immigrants exclusion---plans.

## City Conducting Remote Virtual Inspections

Even with the COVID-19 crisis, the City's Code Compliance staff continues to perform inspections while observing social distancing guidelines. With these precautionary measures in place, staff wants to reassure residents and business owners that code compliance staff will continue to perform inspections for the duration of the current crisis. In lieu of conducting physical inspections of occupied dwellings and businesses, the City is offering a new service to accomplish these types of inspections are known as, "Remote Virtual

Inspections", or RVIs.

RVIs are inspections performed remotely using devices---e.g., cellphones, computers, etc.---with the capabilities to video conference. The City is using tech driven RVIs to continue to provide high-quality customer service to residents and business owners (current and proposed) during critical times. RVIs are available for code compliance residential complaints and inquiries, quality of life inspections, and business license, health and safety inspections. The RVI method of inspection allows the code compliance officer to safely inspect occupied dwellings while continuing to perform required inspections in a timely manner.

"A RVI is an efficient and effective service provided to the residents and business owners in Clarkston with public safety top of mind and practice", said Shawanna Qawiy, Planning & Economic Development Director, City of Clarkston.

Although RVIs will not surpass the customary in-person inspections, they do address how to prepare for, conduct and participate in remote virtual types of interactions which are the norm during challenging times.



## City Conducting Remote Virtual Inspections *(Continued)*

### How to Schedule a RVI:

1. Contact the Code Compliance officer at [ssmith@cityofclarkston.com](mailto:ssmith@cityofclarkston.com) or 678 939 7916 to request an inspection.
2. Schedule an appointment Monday through Friday during the business hours of 8:30am -4:30pm.
3. The requester shall send an email or call the code compliance officer with the following information:
  - a. Time
  - b. Date
  - c. Location Address
  - d. Type of Inspection
  - e. Consent to conduct a RVI
4. A confirmation email will be sent to the requester acknowledging the inspection and to conduct a RVI.

### How to Prepare for a RVI:

1. Have a legal adult be in attendance during the RVI.
2. Make sure proper lighting is available to view the space to be inspected.
3. Follow all instructions given by the compliance officer.
4. Be prepared to answer any questions from the compliance officer during the inspection.

### What to Expect During a RVI:

1. The code officer will confirm a legal adult is in attendance during the inspection.
2. A remote walk through with the requester and the code officer.
3. The code officer will ask questions, write down notes or comments during the inspection.

### What to Expect After a RVI:

Inspection results will be entered into the City's code compliance database within a timely manner of the completed RVI. The code compliance officer will email the customer within 24 hours of the RVI with all comments and if needed, requests for additional information.

The City will continue to document and research ways to improve and promote the RVIs services and processes, while taking advantage of the opportunity to achieve another level of service, reduce cost, increase efficiency and to save time.



## New 4-Way Traffic STOP

As part of the City of Clarkston's continued Streetscape Construction, the intersection of Market Street and Vaughan Street is NOW a 4-WAY (all way) STOP.

Drivers are to adhere to the posted signs by coming to a complete STOP at this intersection. Please continue to observe all posted speed limits, obey all posted signs, and most importantly, to wear your seat belt. Drive carefully and attentively!

## Five Things To Do When Stopped By Police

**Carefully Choose Where You Stop:** When pulled over, do not get off the road if it has a narrow shoulder or little room for your vehicle and for the officer to safely stand between a vehicle and the road. Instead, use turn signal or hazards to let the officer know that you intend to stop when a wider, safer and well-lit area is located. Don't keep driving indefinitely — pulling off the road quickly is advised — but choose a safe location for you and the officer, as many officers die every year as a result of roadside accidents.



**Make Yourself Visible:** After stopping, day or night, shut off the vehicle and any music; sit still with both hands on the steering wheel. After the officer approaches your vehicle, especially at night, ask the officer for consent to make yourself more visible, ideally by turning on the light inside the car to make the officer and you more comfortable. Do not scramble at any time during the stop; as scrambling could lead the officer to believe that you are scrambling to hide contraband or getting a weapon.



**Roll Down Window After Officer Arrives At Vehicle:** With the officer's consent to do so, roll down your window to easily communicate with the officer. If for some reason you are not able to roll down the window — a broken automatic window system, for example — make sure that you communicate this clearly to the officer when they arrive at the vehicle. Do not make a move to open the door or do anything else unless you're told to by the officer.

## Five Things To Do When Stopped By Police *(Continued)*



**Do Not Reach For Anything:** With your hands placed on the steering wheel wait until the officer asks you to provide your license and proof of insurance. After the officer asks for these items, you should inform the officer where they are kept and then tell the officer that you intend to reach for them. Once the officer has verbally confirmed that he or she knows what you are doing, then you can proceed with getting those items. Upon the officer has these items in hand, place your hands back on the steering wheel and sit still while the officer verifies your provided information in his/her vehicle. Calmly await the officer's return to your vehicle to issue further or concluding instructions.



**Be Polite, Be Respectful:** Everyone involved in any encounter with the police should be polite and respectful. Being polite and respectful, oftentimes, leads to better interactions and outcomes for everybody. Drivers should always follow officers' instructions, and avoid the urge to ramble when responding to any officer. Being polite and respectful and responding with yes or no answers, will go a long way to improve and facilitate safer, more productive and favorable results.

To that end, she will make this vigil an annual occurrence in Clarkston. **National domestic violence statistics confirm the need for such awareness: nearly 20 people per minute are physically abused by an intimate partner in the US, one in four women and one in 9 men experience severe intimate partner physical and sexual violence, 1 in 10 women have been raped by an intimate partner, 1 in 4 women and 1 in 7 men have been victims of severe physical violence---beating, burning, strangling---by an intimate partner in their lifetime.**

The City was presented with opportunities to replace typical landscape plantings during three (3) of its active city infrastructure projects. These plantings allow the City to utilize alternative landscaping designs that incorporates urban agriculture plants and land usage.

Known in the industry as “Urban Productive Landscaping”, this new approach to landscaping weaves edible and non-edible native plants at “high pedestrian” locations whereby the public can visualize and be educated on non-traditional landscape plantings. This non-traditional approach can also result in less maintenance and as important, increase the cohesiveness of a community through social interaction.

“Urban Productive Landscaping” planting locations in Clarkston include Refuge Coffee, E. Ponce and Market Street, Friendship Forest Wild Life Sanctuary and Brockett Triangle.



## District 4 Community and Senior Center Enters Final Pre-Construction Phase



The final pre-construction phase of what will be the newest Community and Senior Center near Clarkston is underway and has moved into the planning of the center's design, engineering, and programming specifics.

This District 4 center will be located on County owned land at 4875 Elam Road, Stone Mountain, Georgia. Construction site for the center was determined by a 2016 Comprehensive Feasibility Study that identified the area as a high priority for senior services and community activities. ## Voting, Voting, Voting, VOTED!



DeKalb County residents are not letting long lines deter them from casting their ballots during in-person Early Voting. More than 253,760 DeKalb voters have already exercised their right to vote. **Deadline to vote early is Friday, October 30, 2020, before Election Day, November 3, 2020.** Drop Boxes and in-person drop off at DeKalb's Voter Registration and Elections office (4380 Memorial Drive, Suite 300, Decatur, 30032) remain voting options until 7:00PM on Election Day.



To date, October 30<sup>th</sup>, Georgia has a 71% increase in Total Turnout, according to the Secretary of State reporting data. And a 27% increase in Total Early, In-Person Turnout (to date as of October 30<sup>th</sup>).

Of the more than 7.6 million registered Georgia voters, according to state reported early voting data, in Georgia as of October 29<sup>th</sup>, the total number of in-person ballots casted is 3,619,278.

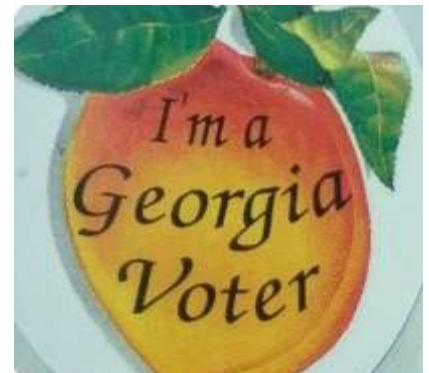

The following is a cumulative summary of statewide advance in-person voting and vote-by-mail turnout as of today:

#### NOVEMBER 08, 2016 GENERAL STATEWIDE TURNOUT

> Number of ballots cast:	2,381,816
> Number of ballots voted in person:	2,200,117
> Number of mail-in ballots returned:	181,289
> Number of mail-in ballots outstanding:	62,186

Per a release issued from the Secretary of State office, the percentage in first day total turnout, as of Tuesday October 20<sup>th</sup>, was 142% over 2016's turnout. In 2016, 90,000 voters showed up on the first day of Early Voting; in 2020 more than 128,000 voters casted ballots, a 40% increase, shattering all of 2016 stats and records, comparatively.

## COVID-19 vs. the Flu vs. a Cold

Cold and Flu season has arrived amidst the COVID-19 pandemic. So now, more than ever, it is important to know the differences and the similarities between a common cold, the flu and COVID-19.

**Colds:** The [common cold](#) is a viral infection of the upper respiratory system (nose, throat, sinuses, Eustachian tubes, trachea, larynx, and bronchial tubes). Rhinoviruses cause about 30%-50% of colds. However, more than 200 different [viruses](#) may cause the common cold. Colds are [contagious](#), can spread from person to person, and have an incubation period of about 1-7 days. A cold's duration (how long it lasts) is about 7-10 days. However, depending upon the viral strain, a cold can last up to 2 weeks. Colds are a mild upper respiratory illness with a runny, stuffy nose without [fever](#). Doctors mainly diagnose colds using clinical observation and medical history. No tests are necessary.

**Flu (influenza):** Influenza (commonly termed the flu) is a viral infection of the upper respiratory and/or lower respiratory system. Influenza viruses cause the flu. These viruses usually cause more serious symptoms in the respiratory system than cold-causing viruses. The flu is contagious, can spread from person to person, and has an incubation period of about 1-4 days. The flu's duration varies from about 5 days to 2 weeks depending upon the severity of the infection. The flu can become an intense and potentially fatal illness ([pneumonia](#)) in some individuals. Hallmarks of the flu include mild to high fever, moderate to severe [headache](#), [cough](#), [fatigue](#), and body aches/pains. Severe flu may have symptoms that develop rapidly and require supportive care. Doctors diagnose the flu based on clinical symptoms and by readily available lab tests.

**COVID-19 (2019 novel coronavirus):** Is a single-stranded, positive-sense RNA coronavirus. It is a new strain of coronavirus (the term *corona* means [crown](#)) responsible for causing a pandemic of serious respiratory problems that started in Wuhan, China. Researchers believe it originated from infected animals and jumped over to infecting people in a large open seafood/animal market. Also, it has been able to spread from person to person and is

rapidly spreading worldwide. It is related to the [SARS](#) and [MERS](#) coronaviruses. It has an incubation period ranging from 2-14 days. Person-to-person spread may happen even if the infected person has no symptoms during the incubation period. Infected people may also not be aware they have the virus and may not show symptoms. The main symptoms of COVID-19 are fever (usually high), moderate to severe [coughing](#), and shortness of breath. Other symptoms and signs may include a [sore throat](#), [diarrhea](#), body aches and pains, and a stuffy or runny nose. At first, it seemed to target people over 60 years old and have severe underlying health conditions like [heart disease](#), lung disease, and [diabetes](#), but recent data from Italy suggests that people 20-60 years of age may get the disease at about the same rate. About 80% recover without specific treatment, while about 20% may require some respiratory support (oxygen and/or ventilator support).

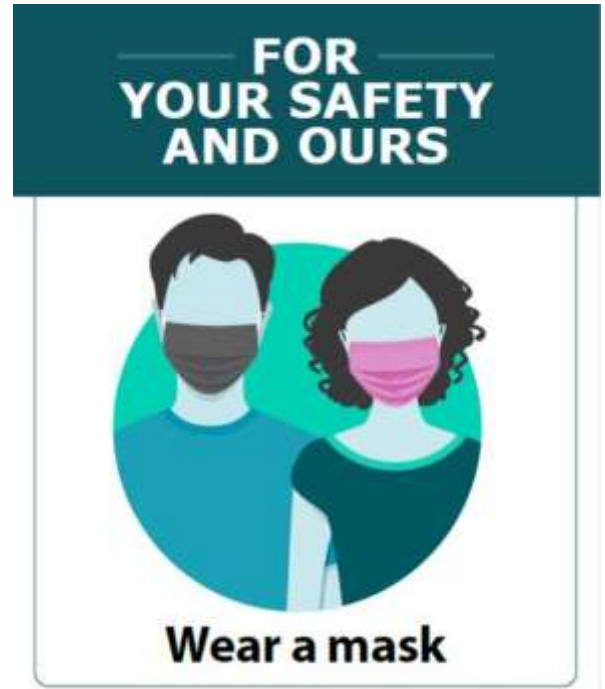

### PROTECTING WATER QUALITY from URBAN RUNOFF

**I**n urban and suburban areas, much of the land surface is covered by buildings and pavement, which do not allow rain and snowmelt to soak into the ground. Instead, most developed areas rely on storm drains to carry large amounts of runoff from roofs and paved areas to nearby waterways. The stormwater runoff carries pollutants such as oil, dirt, chemicals, and lawn fertilizers directly to streams and rivers, where they seriously harm water quality. To protect surface water quality and groundwater resources, development should be designed and built to minimize increases in runoff.

#### How Urbanized Areas Affect Water Quality

**-Increased Runoff-**


 Did you know that because of impervious surfaces like pavement and rooftops, a typical city block generates more than 5 times more runoff than a woodland area of the same size?

**-Increased Pollutant Loads-**

Urbanization increases the variety and amount of pollutants carried into streams, rivers, and lakes. The pollutants include:

- Sediment
- Oil, grease, and toxic chemicals from motor vehicles
- Trash & Debris
- Pesticides and nutrients from lawns and gardens
- Viruses, bacteria, and nutrients from pet waste and failing septic systems
- Heavy metals from roof shingles, motor vehicles, and other sources

These pollutants can harm fish and wildlife populations, kill native vegetation, foul drinking water supplies, and make recreational areas unsafe and unpleasant.
