

FIRSTAMENDMENT TO  
SERVICE AGREEMENT BETWEEN  
THE CITY OF CLARKSTON, GEORGIA  
AND  
GEORGIA WASTE SYSTEMS, INC.

THIS FIRST AMENDMENT, made this \_\_\_\_\_ day of \_\_\_\_\_, 2014, to the Agreement dated July 26, 2011, (the “Agreement”) by and between the City of Clarkston, Georgia (the “City”), and Georgia Waste Systems, Inc., a Georgia corporation (the “Contractor”).

WHEREAS, the City and Contractor desire to extend the term of the Agreement for an additional period of five years; and

WHEREAS, the Contractor has agreed to forego the C.P.I. increase that would otherwise take effect on January 1, 2015 in consideration of the City’s agreement to extend the Agreement;

NOW, THEREFORE, the City and Contractor agree as follows:

Section 1. Term. The term of the Agreement shall be extended for an additional five (5) year term beginning January 1, 2015 and ending December 31, 2019, unless otherwise extended. The parties may extend the Agreement for additional periods of time upon mutual agreement. Either party may terminate its obligations hereunder at the close of each calendar year during the term hereof. Any decision by a party to terminate in accordance with this provision shall be given by written notice to the other party at least sixty (60) days prior to the end of the calendar year.

Section 2. C.P.I. In consideration of the City’s agreement to extend the Agreement through December 31, 2019, Contractor agrees to forego the C.P.I. adjustment which otherwise take effect January 1, 2015. Thereafter, C.P.I. adjustments shall occur each January 1 for the remainder of the Agreement.

Section 2. Modification of Contract. Except as expressly set forth herein or as necessary to carry out the terms of this Amendment and the Agreement, no amendment of the terms of the Agreement is intended hereby and the Agreement and all its terms and conditions, including, but not limited to C.P.I. adjustments, shall remain in full force and effect.

Section 3. Entirety. This Amendment is hereby incorporated into the Agreement and together therewith they contain the entire Agreement between the parties as to the matters contained therein. Any oral representations or modifications concerning this Agreement shall be of no force and effect.
