# CITY OF CLARKSTON HOOKAH PERMIT APPLICATION FOR RESTAURANTS

## **HOOKAH PERMIT REQUIREMENTS**

Only issued to restaurants licensed to operate within the City and actually operating as a restaurant on April 3, 2018.

Approved permits allow limited smoking of hookah within the restaurant.

Permits expire on December 31 of each year, without creating any right to nor expectation of renewal for any subsequent year.

An annual regulatory permit fee of One Thousand (\$1,000.00) Dollars shall be paid to the City prior to issuance of a hookah permit.

### **The following regulations will be strictly enforced at restaurants holding a hookah license:**

- 1.) No person under the age of 18 years old is permitted inside the establishment at any time.
- 2.) No smoking of any type is permitted before 9:00 p.m.
- 3.) After 9:00 p.m., only smoking of hookah is permitted; all other smoking remains prohibited.
- 4.) No person under the age of 21 years old is permitted inside the establishment after 9:00 p.m.

If the owner or operator of a restaurant holding a hookah permit is convicted of any violation of this Article in Municipal Court, the hookah permit for that establishment shall be automatically revoked. No refund will be issued for the permit fee.
