<u>PURPOSE</u>: To adopt the 2019 Millage Rate.

<u>NEED/ IMPACT</u>: The current 2019 projected Clarkston Net Tax Digest is <u>\$209,105,296</u>. The 2018 Net Tax Digest for Clarkston was <u>\$166,859,487</u>. This represents an increase of \$42,245,809 or 25.3% in our Net Tax Digest.

The calculated rollback millage rate for 2019 (rate for the city to receive the same tax amounts as last year) is **13.283 mils.** The rollback millage rate for 2019 is lower than the 2018 adopted millage rate of 15.89 mils due to the increase in the net digest valuation.

The Council must hold three public hearings if the advertised millage rate is higher than the millage rollback rate. The purpose of the meetings is to take public comment on the millage rate for consideration of the final adopted rate. There must be 5 days between the public hearings. Two meetings can be held on the same day with one starting prior to noon and one meeting must start between 6-7pm.

The mathematical millage rate required to balance the FY2019 budget is **17.296 mils.** The FY2019 budget was approved with the understanding that an approximate increase of 2 mils would be needed in FY2019 to balance the budget. Staff has reviewed the FY2019 Budget and identified a net budget decrease of \$294,138 that will decrease the millage rate needed to balance the budget to 15.89 mils.

RECOMMENDATIONS:

Staff recommends The City Council adopt a Millage Rate of **15.890 mils** for fiscal year 2019.
