#### **EXHIBIT B**

#### SPECIFICATIONS AND SCOPE OF WORK

#### **Contract Duration:**

120 calendar days

#### **Project Limits:**

Church Street sidewalk construction from the end of the existing sidewalk at the Mell Ave Trailhead Park to Lovejoy Street and Lovejoy Street from the Church Street intersection to the PATH trail – approximately 600 feet.

### **Project Description**:

The Church and Lovejoy Street sidewalk project scope includes 4-5 ft. sidewalk construction and use of pervious rubberized asphalt at specific locations (at specimen tree root zones), a 12-18 inch 18 inch grass "beauty strip", catch basin reconstruction, resetting existing granite curb, driveway reconstruction, pedestrian ramps, streetscape furniture installation, mailbox resetting or replacement, new retaining wall, handrail and a CMU wall reconstruction. No utility relocations are anticipated.

#### Scope

The contractor shall furnish all materials, equipment, and labor to complete the required construction as described in its entirety to the Project Plans and Specifications and the terms of this contract including all incidentals as directed by the Project Engineer for the City of Clarkston Unless otherwise specified all work shall be completed in accordance with Georgia Department of Transportation Standard Specifications (current edition), by a completion date.

The selected contractor shall also be responsible funding the cost of all material testing associated with this project. The selected materials testing firm must be GDOT pre-qualified. Testing frequency shall be no less than 1 set of 3 cyclinders per 50 CY of concrete per day for all retaining wall and sidewalk work tasks.
