#### "ACTIVE LIVING PROJECT – PEDESTRIAN SAFETY & ACCESS TO FACILITIES"

**<u>Project Limits</u>**: East Ponce de Leon Ave (south side) from approximately Tree Creek Apartments to approximately Post Oak Drive

Project Length: Approximately 1400 feet

**<u>Project Justification</u>**: The project entails the construction of pedestrian improvements that will provide accessibility for that census tract in Clarkston where socioeconomic conditions offer limited access to sidewalks for the low-income and immigrant constituents of the community. The physical barriers to accessibility are clearly evident within the project limits as shown on the attached Exhibits.

Within the project limits, pedestrians and those that are wheel-chair bound must utilize the roadway pavement or dirt paths to access MARTA bus stops or to shop at markets. For the wheel chair bound residents in this area, "dirt path" accessibility is not an option and as such, these individuals are forced to utilize the roadway pavement (in lieu of sidewalks) to access several MARTA Bus Stops or to shop at the nearby commercial centers. In addition, no concrete pads or ADA ramps exist at any of the MARTA Bus Stops within the project limits. This lack of pedestrian infrastructure is problematic for all users.

**Project Description**: The pedestrian improvements proposed will consist of constructing new 5 foot sidewalks, removal of broken granite header curb and installation of new concrete and/or granite header curb where sidewalks are to be constructed, install new and/or removal of non-complaint ADA ramps (10) & four (4) new concrete pads, thermoplastic striping of four (4) new crosswalks and restripe three existing with corresponding signage, two new pedestrian push button poles/signal heads, safety fencing or handrails where fill slopes are less than 2:1, 8 ft. x 14 ft. concrete pads at four MARTA bus stops, assess pedestrian signal timing/new signal phasing at Brockett/East Ponce intersection and new bus pulloff at existing MARTA bus shelter (Brocket's Tavern parcel)
